## VIII. Officer and Member Reports

**President – Jasmine Hill**

Hill said that all officers must determine which standing committees they will sit on. She asked council to forward preferences to her electronically. She said that the three committees to choose from are CRC, ARC, and BRC. Hill will be speaking at the CAL Grants rally tomorrow morning in downtown Los Angeles. She is also completing her proposal for a scholarship program to Chancellor Block. She is also working on fundraising, and discussing ways to raise funds to support the program. She would like to schedule one-on-one meetings to discuss goals for the year and how to make the council work cohesively.

**Internal Vice President – Stephanie Lucas**

Lucas thanked students in attendance for electing the council members in attendance. She is hiring a new staff and working toward forming a more cohesive bond with the administration.

**External Vice President--Chris Santos**

Santos said that the rally held outside of the Los Angeles Office of the Governor will be taking place tomorrow. The governor is proposing a cut to competitive CAL Grants, which Santos feels opens the door for further attacks on the program. Santos said that he will be working to discuss the need to protect the CAL Grants program. In terms of transportation, buses will be departing for the event from Ackerman Turnaround at 12PM, and will return by 3:30PM. The intention of the rally is to ask the governor to keep his promise to protect higher education funding and to drop the proposal. Santos said that his office will also continue work on the federal DREAM Act, and mentioned the importance of the act. Santos feels that the recent development of certain laws (Arizona SB 1070) have opened the door for an influx of similar laws to fill the nation. The focus will be on bringing a new focus to the DREAM Act. A press meeting to be held outside of the office of Senator Dianne Feinstein has been called to emphasize the need to handle the act as a stand alone bill. Finally, applications for his office will be made available sometime this week.

**Academic Affairs Commissioner--Suza Khy**

Khy said that she will be continuing the work with administrators to develop a community which addresses issues of diversity. Academic Senate and staff applications will be prepared by next week.

**Administrative Representative—Berky Nelson**

Nelson welcomed the new council to the table, and said that he looks forward to the upcoming year .

**Administrative Representative—Deb Geller**

Within the room, Geller will do her best to lead the council along the bylaws set forth by the university. She looks forward to getting to know the council.

**Alumni Representative—Willard Tressel**

Tressel also welcomed the new council members.

**Patricia Zimmerman**

-Zimmerman passed out contact information sheets for council to provide information for student services. She also discussed the ASUCLA email account, and said that all accounts relevant to the council should be linked to the ASUCLA email. She passed along all documentation regarding office allocations.
