IV. Public Comment

King

- Clara Castronova: "Hello, my name is Clara. I am the CALPIRG chapter chair here at UCLA and I am here to give a weekly update for our organization. For those of you who may not know, CALPIRG students is a student run student funded non profit organization with chapters across the state. We work to protect the environment and public health, make college more affordable, and promote civic engagement. Over the years, we have done things like protect billions of dollars of Pell Grant funding. In the 2020 election, we registered over 10,000 students to vote and we phased out the UCS from single use plastics. We are currently working on a sustainability festival in Bruin plaza during week 10 and ourselves and some other student groups are going to educate students on issues of sustainability through activities. We hope it will be an opportunity for students to destress before finals and learn something new before the upcoming elections, both the primaries which will be the following week and the midterms in november where there are environmental measures on the ballot. Finally I have reached out with all of you to set up a meeting to talk more about CALPIRG and how we can work together and discuss how you can help us and urge the city council to pass legislation on the issue of plastic pollution. So if you could check your inboxes and get back to me that would be awesome. Thank you so much."
- Ananya Visweswaran: "In march of 2021, USAC passed a resolution calling for the UC to divest from war and weapons manufacturing and halt all relationships with the Black Rock investment firm. Despite this resolution, the UC continues to partner with Black Rock; a firm that invests in several UCs and weapons manufacturing which is used to perpetuate violence against marginalized communities in the US and many occupied and oppressed people in the global south. So the UC regents are meeting this week on UCLA's campus and on their agenda are discussion on investments and financial strategy. I am representing a coalition of organizations UC Divest. We are intended to put pressure on the regents and the administration to follow through with the desire of the student body who has voted to divest from war and violence. So tomorrow when the bulk of their meetings will take place, the UC divest coalition will be hosting an all day sit-in with a rally from 12-2pm outside the Luskin Conference Center and hotel. We are calling on UCLA students and USAC to support our action tomorrow and to help put pressure on the administration to stop investing in

war and violence. Divest campaigns have a long history of success pushing against violence and apartheid. It has been used frequently in the past by USAC itself and it is something that all of us should support. Please show your support and commitment to opposing violence, war and occupation by supporting the UC Divest coalition and the actions tomorrow and in the future. Thanks.”

- Josh: "Hi everybody, so you all have heard enough from me today but I do want to say that if any of you are having any issues with transition documents, reports, log ins, please make sure you reach out to Jessica, Orlando, Patty, or myself so we can help you with that transition if need be. If there is anything that you need from us, any questions that you have, any how does this work, this doesn't make sense, don't hesitate to reach out. You all have our contact information so we are here to support you. So far, you all are doing amazing on your first meeting. Great leadership by Carl in this meeting and all of you have done an amazing amazing job. So just 51 more weeks to go ! Yes! Thank you!"
- Orlando: "Hello everyone, just once again, Congratulations and to go off what Josh was saying. Definitely reach out if you have any questions. As I was saying, I do come from the SOLE office, so don't forget to update any signatories or signatures information for these organizations or any other organizations that you help represent. This is the time of year where this transition occurs and you don't want the new leaders to miss out on new information. Please don't hesitate to reach out."
- Jessica: "Hello everybody, I just have a couple quick little updates that I wanted to mention. As you prepare to get access to your physical office space, we did give the outgoing council members two weeks to clean up and clear out their stuff. You don't have access to funds, but we can still answer questions and help you understand what your office budget typically looks like. We also have a training on Friday so hopefully you all can join us there. If not, we will be in contact to give you the information and make sure to answer questions. I think that is it for now. If you have any questions let me know."

Maybe I can do a Special Presentation breaking it down, so you all have a better understanding of what the Alumni Association does. I will talk to Carl about that as well in the future. - E. Resolution: Philippines Election* Cortez
A Resolution in Support of Pilipinx Students at UCLA in Light of Recent Electoral Events in the Philippines

Sponsors: Daniela Anais Cortez Bravo, Academic Affairs Commissioner; Alicia Verdugo, Cultural Affairs Commissioner; Naomi Michelle Hammonds, General Representative #2

WHEREAS, the 2022 Philippine elections occurred on May 9, 2022; and

WHEREAS, officials announced in preliminary election results that Ferdinand Marcos Jr. and Sara Duterte received a majority of votes for the office of the President and Vice President of the Republic of the Philippines; and

WHEREAS, Sara Duterte’s father and the current president of the Philippines, Rodrigo Duterte, signed into law the Anti-Terror Act of 2020, undeniably infringing upon the people’s right to expression and protest¹; and

WHEREAS, Rodrigo Duterte’s reign has been marked by widespread extrajudicial murder committed under his “war on drugs” campaign, leading to the deaths of over 12,000 Pilipinx²; and

WHEREAS, Rodrigo Duterte has endangered the lives of Pilipinx people with his campaigns of terror and increased amounts of policing and militarism to oppress journalists, activists, and citizens; and

WHEREAS, Ferdinand Marcos Jr.'s father, Ferdinand Marcos Sr., established martial law in the Philippines in 1972, resulting in 3,257 deaths; 35,000 instances of torture; and 70,000 arrests³; and

WHEREAS, under Ferdinand Marcos Sr.'s reign, Indigenous Peoples such as the Igorot, Lumad, and Moro communities suffered the destruction of their ancestral lands by multinational corporations, the displacement of hundreds of thousands of Indigenous Peoples from their homes, and mass murder and violence against Indigenous Peoples⁴; and

WHEREAS, the rampant corruption and cronyism of Ferdinand Marcos Sr.'s regime plunged the Philippine economy into the worst crisis it has ever had, putting 59% of the country into poverty. These same economic policies resulted in the current diaspora of Pilipinx overseas workers and a wave of immigration to the United States^{5,6}; and

WHEREAS, Ferdinand Marcos Sr. was ousted in the People Power Revolution, a mass action consisting of millions of Pilipinx peoples taking to the streets in protest of the dictatorship⁷; and

WHEREAS, many Pilipinx-Americans, particularly those at UCLA, stood in solidarity with anti-Marcos groups in the Philippines by participating in actions such as the Far West People's Conventions⁸; and

WHEREAS, Ferdinand Marcos Jr. and his family have emphatically denied the wrongdoings of Ferdinand Marcos Sr., engaging in egregious historical revisionism by using their vast wealth, political connections, and mass media control⁹; and

WHEREAS, the Marcos-Duterte tandem have pledged to continue the violent legacy of president Rodrigo Duterte¹⁰; and

WHEREAS, the resurgence of the Marcoses and the rise of the Dutertes are emblematic of the endemic corruption within the dynastic politics of the Philippines, which has resulted in as many as 90% of elected offices being controlled by dynastic families¹¹; and

WHEREAS, the United States has actively facilitated the corrupt politics of the Philippines by socially, economically, and militarily backing both the Marcos and Duterte regimes^{12,13}; and

WHEREAS, there are Pilipinx students, faculty, and service workers who are deeply concerned about or have been personally affected by the Marcos and Duterte dynasties; many Pilipinx students, particularly those with family still in the Philippines, have expressed constant fear and anxiety about the safety of their families, posing a direct threat to their retention; and

WHEREAS, the COVID-19 pandemic has had disproportionate effects on the Pilipinx-American community, exacerbating the feelings that many Pilipinx-Americans are currently feeling.¹⁴

THEREFORE, LET IT BE RESOLVED, that the Undergraduate Student Association Council stands in solidarity with our Pilipinx students whose families, communities, and homelands are being put directly at risk by the Marcos-Duterte tandem.

LET IT FURTHER BE RESOLVED, that the Undergraduate Student Association Council resoundingly condemns the United States' support by the Biden administration of the Marcos-Duterte presumptive victory.¹⁵

LET IT BE FURTHER RESOLVED, that the Undergraduate Student Association Council calls on university faculty and administration to take a public stance condemning Ferdinand Marcos Jr. and Sara Duterte

LET IT BE FURTHER RESOLVED, that as a result from widespread misinformation by the Marcos-Duterte candidacy and the use of faulty machinery for election polling results¹⁶, the Undergraduate Student Association Council joins in support of the organizations calling upon the conduct of an investigation of the 2022 Philippine Elections¹⁷

LET IT BE FURTHER RESOLVED, that the Undergraduate Student Association Council calls on the Academic Senate and academic departments at UCLA to implement academic leniency for all Pilipinx students who have been affected by the results of this recent election in the Philippines, in accordance with the traumatic responses that this news may trigger.

LET IT BE FURTHER RESOLVED, that the Undergraduate Student Association Council calls on the UCLA community at large to extend empathy and understanding to Pilipinx students in a holistic manner, through academic leniency, offering psychological resources, and exemplifying solidarity with the Pilipinx community.

LET IT BE FURTHER RESOLVED, that in their public stance, the university must also acknowledge the historical roots that contextualize the extreme harm of these electoral results in order to advance a collective, institution-wide consciousness, of these histories.

LET IT BE FURTHER RESOLVED, that with the election of Marcos-Duterte, the Undergraduate Student Association Council stands fervently in support of the Philippine Human Rights Act, established in response to Duterte's terrorization of the Pilipinx community during his term, and demands that the UCLA administration endorse it as well to pressure government authorities to divest from US-Philippine arms deals and further violation of human rights.¹⁸

LET IT BE FURTHER RESOLVED, that the Undergraduate Student Association Council recognizes that throughout its history, UCLA has invested in social structures, institutions, and corporations that profit from white supremacy, cisheteropatriarchy, and imperialism. Today, UCLA is part and parcel of the U.S. police force, itself an extension of the U.S. war machine, spreading its technologies, weapons, and tactics across the streets of Afghanistan, Iraq, Palestine, the Philippines, Mauna Kea, Somalia, Cuba, Brazil, Mexico, native nations and reservations, Akwesasne of the Kanienkehaka (Mohawk) Nation, San Diego, U.S. border lands, and Los Angeles, which is why the Undergraduate Student Association Council supports UC divest.¹⁹

LET IT BE FURTHER RESOLVED, that the Undergraduate Student Association Council opposes the University's abominable profiting from death.

H. [Resolution: Expanded Hybrid Learning and Work Options*](#) Sisman
A Resolution for Universal Hybrid Access and Solidarity with Disabled and Parenting Students, Faculty and Workers

Whereas, hybrid learning is essential for many students, especially those who are disabled, parenting, international, and/or commuter students.

Whereas, the Disabled Students Union, the Undergraduate Students Association Council (USAC), and Mother Organizations have been advocating for hybrid learning for more than a year, and have demonstrated that hybrid learning is popular with UCLA students by getting more than 30,000 signatures on petitions for hybrid learning²⁰ and building a coalition of organizations representing most UCLA students for the Strike For Our Safety which had hybrid learning as a central demand²¹.

Whereas, the lack of hybrid access has placed many disabled, parenting and other students in danger of being unable to complete their degrees, despite their hard work and dedication to learning, and has caused many others to endure unnecessary and severe pain, fatigue, exacerbation of their physical and psychological conditions, and the risk of death from contracting COVID while immunocompromised²².

Whereas, hybrid learning would make UCLA more sustainable by decreasing the need for students, faculty and workers to commute to and from the campus²³.

Whereas, UCLA's administration and Academic Senate have expressed their commitments to equity²⁴, which means actively correcting all forms of oppression and barriers to the full flourishing of marginalized communities and building new structures which serve all people fully and equally, and hybrid learning is a necessary component of equity for disabled, parenting, international, and commuter students and for students of color and low-income students who face higher risks from COVID-19 due to environmental, economic and medical injustice.

Therefore, let it be resolved, that the USAC calls for the Academic Senate to require hybrid access for all classes, and failing that, to establish sufficient hybrid access so any student can get a degree with any major, concentration or minor while only taking hybrid classes.

Let it further be resolved that the USAC calls on the Academic Senate and administration to work with and provide resources to IT services so that our great IT workers can expand Bruincast and other technological resources.

Let it further be resolved that the USAC calls on the UCLA administration to support CLICC in expanding their technological services so that hybrid learning and dual modality learning is equally accessible to all students by mitigating any technological barriers that students may face.

Let it further be resolved that the USAC calls on both the Academic Senate and the administration to allow UCLA workers, faculty, and grad students to work remotely whenever this is physically possible, and to be provided with adequate PPE and accommodations in all cases.

Let it further be resolved that the USAC urges that administration provide all technology, logistical support and other resources needed for faculty and TAs to easily and smoothly provide hybrid access, and calls for full compensation for the work done by faculty, TAs, staff and students to establish and preserve access.

Let it finally be resolved that the USAC expresses appreciation for the dedicated and compassionate activism of the Disabled Students Union and the Mother Organizations and of all disabled, parenting and minority students, and urges that the administration and Academic Senate consult with these groups before making decisions about accessibility, retention and COVID-19 response.

- Kian moves to approve A Resolution Expanding Hybrid Learning and Work Options, Juan seconds.
- By vote of 11-0-0, the motion passes and the Resolution Expanding Hybrid Learning and Work Options is approved.

I. Discussion on Mass Shooting in Buffalo, NY

- Daniela: "My commentary on this subject isn't anything that is super extensive as of right now. I know when I mentioned it to Carl, it was more of throwing it out there because it is something that we should address as a council because there has been a lot of administration extending forward communications. Not only the administration extends forward communications but also things from my department's chair and I definitely think it is something that should be of concern to the council because of the point that we are in the quarter and still being in a pandemic. It definitely influences and plays a role in individual students' well-being and yeah just wanted to put that forth in front of the rest of the council."
- Carl: "Yeah, it was a tragedy and it is something that we can definitely address. I am willing to create a resolution on this and if you want to join in let me or Daniela know and we can start working on that."
